Community Developments - Napa Pipe

The community at large is excited as the Napa Pipe project continues to move forward, a neighboring mixed-used development.

As you may already know, the two primary entrances to this development intersect with the Napa Valley Commons business park. Kaiser Road will be one entrance, where planning for a roundabout at the intersection of Basalt and Kaiser roads is under review. The second entrance will be at the entrance of Anselmo Court and Napa Valley Corporate Drive. Current plans include installation of signal lights at this intersection which will be a welcome improvement to the ever -increasing vehicular traffic.

Napa Valley Commons is working closely with the developer regarding these intersections. To help accommodate the anticipated increase in pedestrian traffic, the Board of Directors has negotiated with the developer to install single-sided sidewalks exiting from Anselmo Court, wrapping around the Venture Commerce property, and ultimately connecting to the newly installed crosswalk at Bordeaux Way. Additionally, the developer has agreed to a financial contribution of \$75,000 towards future sidewalk improvements in the community.

We look forward to these improvements and we'll provide development updates as the project progresses.

Leasing Reminder: Signs Require Approval

When marketing a property for lease, the POA encourages you to utilize a highly visible leasing sign.

However, to avoid having to remove an unapproved sign, please submit an application and get approval prior to installation.

The requirements and specifications for leasing signs are outlined in the Association's Master Sign Program and require approval by the Board prior to installation (refer to Master Sign Program in Section 4, "Commercial Use").

Call Before you Dig (U.S.A. Markings)

When making any underground repair, completing landscape renovations, and when undertaking new developments, it's essential that you arrange for Underground Service Alert (USA) markings to identify underground utilities before you dig.

Depending on the project, digging without first checking for underground services can result in damage to your services, neighboring building services or the common area services. USA North 811 coordinates service providers to mainstream the marking process. Often markings can be done within 2 days' notice. **Before you dig, call 811 or visit www.usanorth811.org**



Landscape Frontage Issues - Who to Contact?

The Association is responsible for the landscape maintenance along Napa Valley Commons street frontage. This landscape responsibility is defined by easements and extends between 20-35 feet from the street depending on the location. Beyond these easements, owners are responsible for all of the landscaping on their private lots.
