Median Landscape Design



As previously reported, due to the decline in the original trees planted in the medians, four medians in total were approved to be completely renovated, the two medians on Napa Valley Corporate Way and the first two medians turning onto Napa Valley Corporate Drive from Kaiser Road. These four medians alone account for some 2,200 linear feet of landscape improvements.

We're happy to report that construction is nearing completion, and the landscape contractor awarded the project, Monarch Landscaping, is wrapping up final touches to close the project. No doubt we all look forward to watching the new plant life mature over the coming years and continue to enhance the two primary entrances to the business park.

Proactive Eucalyptus Removal

2024 Election Results

Thank you to all the owners who were able to return ballots for the 2024 director election. There were three (3) candidates for three (3) open director positions. As a result, the outcome of the election was known before the meeting. It was still important to receive enough ballots from owners to hold the election and avoid unnecessary additional costs. 109 votes out of a possible 159 were received. The results were announced at the annual meeting held on August 8, 2024. In addition to the Director election, the ballot included the annual IRS tax resolution for Revenue Ruling 70-604. The ballot results were as follows:

2024 Director Election - 109 Votes Received

Steven Lederer	93 Votes
Edward Pike III	109 Votes
Tony Zand	93 Votes

All three candidates are elected to two (2) terms, ending with the director election held in 2026.

IRS Revenue Ruling 70-604 - 108 Votes Received

Votes in Favor - 93 Votes Opposed - 16

IRS Revenue Ruling Resolution passed.



Along Riversound Way (previously Syar Road), there are two staggered lines of mature eucalyptus trees. About half of these trees are planted in the Association's landscape maintenance easement, primarily the front row closest to the street. Over the last few years, more than 30 of these trees have failed during storms, causing significant damage. Last winter alone, 22 of the Eucalyptus trees fell. Fortunately the trees fell in the direction of the undeveloped Napa Pipe project, avoiding people, vehicles, and buildings and thus causing less damage than what could have been.

With the goal of reducing liability now that the Napa Pipe project is actively being developed and has vehicle and pedestrian movement, the Board has proactively approved the removal of any remaining eucalyptus trees, totaling 58 in the Association easement. The Association has also alerted lot owners of these associated concerns for eucalyptus trees within their lot so that lot owners can also take proactive steps to mitigate the concerns.

The Association's management company conducted a competitive bid process, which was ultimately awarded to a highly qualified low bidder, Astro Green Ventures. The project to remove the trees will take about four weeks and is anticipated to start in November.
