Sidewalks - Pedestrian Improvements

Planning is well underway to continue improving pedestrian infrastructure through the installation of sidewalks. The current priority is to install sidewalks that will connect existing sidewalks and crosswalks, eventually expanding out through the rest of the business park.

To that end, the Board of Directors has awarded a contract for this initial phase to Ghilotti Construction. APM is actively working with them to determine scheduling, which we anticipate to start early this summer.

This project will include the installation of sidewalks extending from the crosswalks at the Bordeaux Way/Napa Valley Corporate Drive intersection, up to the Vista Point roadway entrance.

As previously announced, the eucalyptus trees along Riversound Way, previously Syar Road, have been prone to failure in recent years. With the area now being developed and to eliminate the liability of trees falling on pedestrians or hardscape infrastructure, the Association took the proactive steps of removing the eucalyptus trees that fall within the Association's landscape maintenance easement. This project has now been completed. With a few eucalyptus trees remaining within individual lot owners property lines, the Association encourages lot owners to take proactive steps and consult an arborist to either properly trim the trees to reduce risk of failure or to remove the trees entirely.
